

Supplier Sustainability Policy

1. Purpose

The purpose of this policy is to establish our commitment to working with suppliers who share our values in sustainability, ethical practices, and social responsibility. By promoting sustainable practices throughout our supply chain, we aim to reduce environmental impact, uphold human rights, and contribute to a more sustainable future.

2. Scope

- Prohibit child labor, forced labor, and discrimination in any form.
- Uphold fair labor practices and ensure compliance with ethical sourcing standards.

3.4 Ethical Business Practices

Suppliers must conduct business with integrity by:



- Avoiding corruption, bribery, and unethical practices.
- Maintaining accurate records of business activities.
- Protecting confidential and proprietary information.

3.5 Continuous Improvement

Suppliers are encouraged to adopt innovative solutions and practices that enhance sustainability performance. Regular assessments and feedback will support continuous improvement efforts.

4. Monitoring and Compliance

Suppliers are required to:

- Provide documentation or evidence of compliance with this policy upon request.
- Participate in audits or assessments conducted by DMS or its representatives.

5. Non-Compliance

In cases of non-compliance, DMS will work with the supplier to develop a corrective action plan. Persistent failure to meet the expectations outlined in this policy may result in the termination of the business relationship.

6. Collaboration and Support
